## NETBALL SOUTH AFRICA PRESIDENTIAL REPORT 22 OCTOBER 2022

### OUR CORE BUSINESS SHOULD BE PLAYERS

## 1. PREAMBLE

Life as we knew it has changed completely. The effects of COVID-19 have eroded what we once understood to be our normal. Over the past two years, we have been forced to adopt new ways of doing things and learn alternative ways of doing things. 2022 was always going to be tricky on many fronts- while we were seeing the numbers of people infected by COVID-19 declining and an uptake of people getting vaccinated, this was going to be the first time that people would be able to congregate in large numbers and attend matches for the first time in two years.

This was the first-time post COVID that we opened our doors to spectators – we did not know what to expect, we had missed the exhilarating excitement that the fans bring to our arenas, and this is what we had missed over time. This report will clearly articulate how we fared throughout the year.

## 2. OVERVIEW OF NSA

We are growing as a federation, and this cannot be accomplished without all of you and your support. In this year a lot has happened in different sectors of NSA, from restructuring of Districts and Provinces to the introduction of a new system of capturing our members, to coaching being set at another level of "Coaching and thinking like number ONE, to selection of players and having players being busy and playing as is something that we clearly want to do.





We are not perfect. However, we strive for perfection, and we can only attain that if we all co-operate by working together to grow Netball and make it fashionable.

We are going to take decisions that are not favorable to others however this has nothing to do with being personal but follows the principle of doing the right thing for our lovelysport.

When we work towards one goal, we will all achieve turning this sport fully professional.

### 3. HOSTING EVENTS

# HOST AN EVENT

Hosting events at a time such as this has proven to be a serious challenge and it has therefore required everyone to get onboard and fulfill their roles as best as they should – there is extraordinarily little margin for error.

We took some great lessons from 2020 and 2021, we adopted some best practices from how we hosted events those years and how others did too – we then were able to build a blueprint of how we will host events going forward.

#### 3.1 Males National Championships

2022 was a noticeably big year for our Male National Team. They ended 2021 on a high winning every competition that they entered. This year they were supposed to compete at the first Male Africa Cup in Morocco however due to escalating number of COVID in that country, the event was canceled.

The Males National Champs took place in Upington, Northern Cape and this was the first time that the province hosted an event – they exceeded expectations and hosted a magnificent event.

This event presented the coaches with an opportunity to identify new talent and add depth to his squad.

During this tournament, we were also able to conduct coaching classes under the stewardship of Director Coaches Annelie Lucas assisted By Martha Mosoahle-Samm and Dumisani Chauke.





### 3.2 TELKOM NETBALL LEAGUE



The 2022 Telkom Netball League was the first tournament that we hosted indoors and welcomed spectators. As one would expect, we were a bit nervous during this period because we did not have spectators for two years. We had confidence in our events team, and we believed that we could pull this off.







We hosted a media launch with a few weeks to go before the first game was played. We believed that this was an opportunity for us to reintroduce the game to members of the media and most importantly communicate all the necessary information to them.

Yet again, the Telkom Netball League was a two-legged affair with the first leg of the event being hosted in Durban, KwaZulu Natal. The people of Durban did not disappoint as they filled the arena for

the better part of week. The second and final leg moved to Pretoria.

The Telkom Netball League lived up to expectations as we saw teams stepping onto court and competing, no one came here to add numbers, but everyone was here for competition. Both divisions were tightly contested, and this was very evident in how closely second division was, the Eastern Cape Aloes returned to division A, and we crowned new division A champions after Golden Fireballs dethroned their Juskei River opponents for the title.

### 3.3 TELKOM NETBALL JUNIOR CHAMPIONSHIPS



The Telkom Junior Championships made a return for the second year in a row. This is a partnership that we have with our affiliate member SA Schools Netball and our partner Telkom.

It is for this reason that we have collaborated closely with the team management to make sure that we come up with a programme for the team to follow. Part of the programme meant that we needed to get the team to be stationed at the Stellenbosch Academy of Sports (SAS).

We also managed for the team to play against Wales and Scotland ahead of the 2022 Commonwealth Games in Birmingham. The purpose for these games was to make sure that we prepare the team and give coaches a bit of game time with the players.

This series was organised for the national team before they went into the athlete's village and became part of Team South Africa to represent the country.





We all saw and know that our performance at the Commonwealth Games was not as expected.

However, we are all in agreement that something needs to be done to the team if we really want to end up on the Medal Podium next year when we host, after a disturbing report of this games one can say indeed some drastic steps need to be taken.

### 3.9 2023 NETBALL WORLD CUP AFRICA REGIONAL QUALIFIERS



South Africa have already qualified for the 2023 Netball World Cup since we are ranked fifth (5<sup>th</sup>) in the world and secondly by being hosts. When the opportunity to host the Africa Regional Qualifiers presented itself, we grabbed it and made the most out of it.

We believed that this was an opportunity for us to give our national team another opportunity to get some much-needed game time and prepare. This was a good event for the team especially after the disappointing Commonwealth Games. Our ladies competed at this event without losing a single game and this was a great morale booster for the players.

This was one event that Netball SA should really take pride in even after the challenges we faced we still managed to pull it through. We are aware that things were not as expected however we are thankful to the Department of Sport in Gauteng under the leadership of MEC Mbali Hlophe and all stakeholders including City of Tshwane, Gauteng Netball, Tshwane Netball, University of Pretoria, Gauteng tourism that this pulled through.





Africa Netball under the leadership of Cecilia Molokwane for the first time since its birth managed to get a sponsorship from SABC who the main sponsors of the Africa Qualifiers were, SuperSport, Red Bull and SPAR out did themselves yet again.

We saw Uganda withdraw at the last minute which affected a lot of things especially broadcast and fixture change.

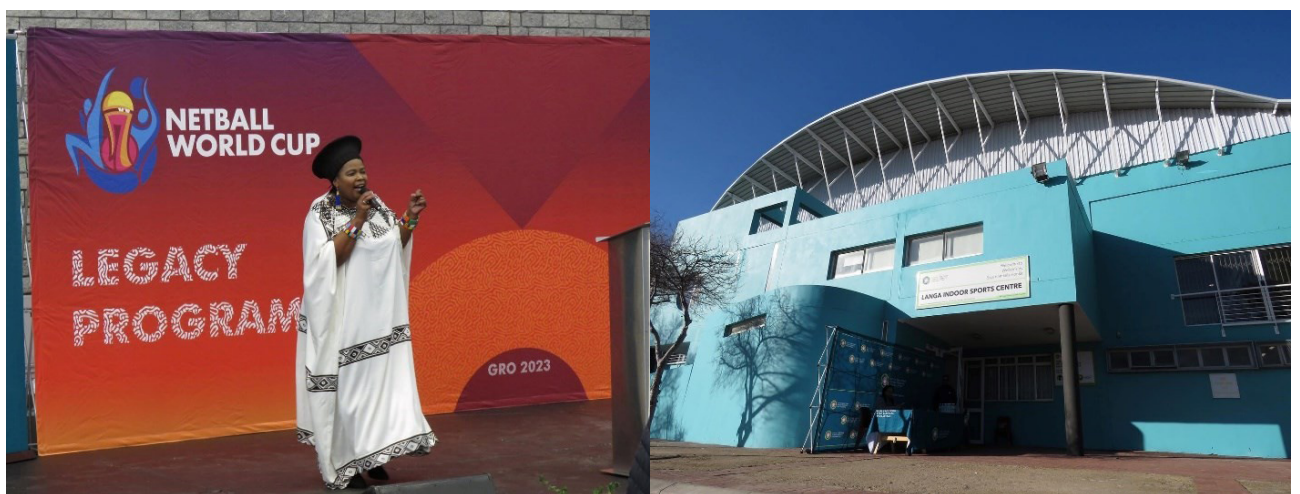




The province on WC is busy as we speak with mobilisation and revamping and concluding to build the 30 courts, they promised in the actual bidding process.

and other Ministers and Director Generals from various departments to see the update and the progress of the 2023 Netball World Cup. NWC2023 is standard on the agenda of the MINMEC until the kick of the event.



Let me say Eastern Cape called us together with the Director Coaches who is the Legacy Manager of 2023 Netball World Cup to do a presentation and we are pleased to say EC government is on board and will work with NSA to make this legacy programme a success.

The City of Cape Town has also been busy revealing Murals with the aim of promoting awareness in the City. 30 Members of Netball South Africa from all 9 provinces were trained on the Champions Data system that will be used at the World Cup, 12 members we identified by Christian from Australia who was training them and proudly said to me he has identified 3 that he can use anytime anywhere in the World is how good how some of our members are.

- Limpopo Vhembe District - On 14 October 2022, the Netball court will be handed over.
- On 21 October 2022, Namaqua was supposed to be opened. Due to unforeseen circumstances, it was postponed to December 2022.

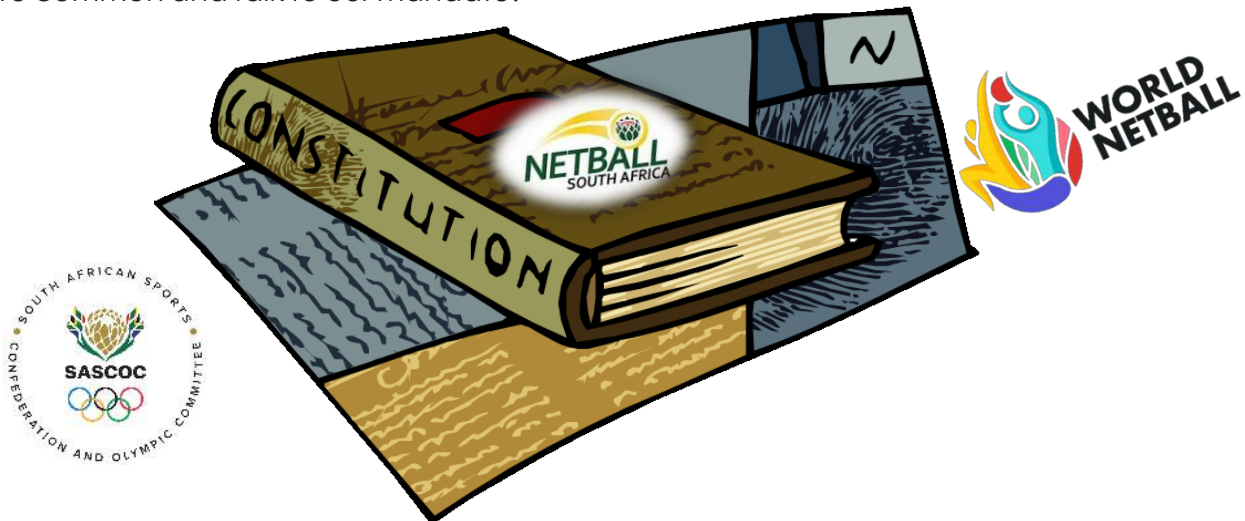
The CEO and I had our first meeting with SARU and a meeting that was successful and opened our eyes to a lot of things we thought we knew and understood, only to find a different view and perspective.

In 2022, our members showed tremendous resilience, responsibility and resolve to support one another, and in so doing have served our most valued asset, the player. We thank the leaders in the districts and provinces who shared in making all our collective achievements possible.

Netball South Africa entered the year on a positive and high note.

We were still in business, and we could deliver on our commitments. Our records reflect a growth in registered membership from 17 773 in 2021 to 22 480 in 2022.

At the 2019 Netball World Cup, the team finished in 4<sup>th</sup> position, only missing out by 2 goals against Australia to make it to the gold medal match. The popularity of netball and the SPAR Proteas among the South Africans was heart-warming. SuperSport partnered with Netball South Africa in support of the Project Victory Programme.

It is truly remarkable to think that 23 of our national team players receive contracts and monthly salaries, this is a first in the history of Netball South Africa and is testament to the growth and professionalization of the sport. The Stellenbosch Academy of Sport is now the home for the team accommodating and servicing the team in the residential programme.

Going into the 2022 Commonwealth Games, the expectation was high, with the significant investment invested in the preparations of the team. The team's performance was however a disappointment to Netball South Africa, supporters, and investors. A performing team creates interest both commercial and publicly which is evident in the ticket sales.

We understood we need to change things to achieve different results - We knew that the "Old ways wouldn't Open New doors."

2020, 2021 and part of 2022 tested everyone, families struggled with the COVID-19 pandemic and personal loss. We are still struggling with the uncertainty of the future. Important questions are raised about the role of sport in society.

- How does the leaders in sport demonstrate responsible leadership?





- How can a non-profit organization like ours deliver on our commitment to provide value to our members and sponsors?
- What are the opportunities to rebuild trust in our investors with a purpose to support and serve everyone with whom we do business.

Over the past few years our investors and supporters showed tremendous resilience, responsibility and resolve to support us (NSA) and our SPAR Proteas. They are the ones that focus on societal issues and have good governance practices. They are the ones with crisis response plans and made us strong in order to host all our events as per our annual calendar.

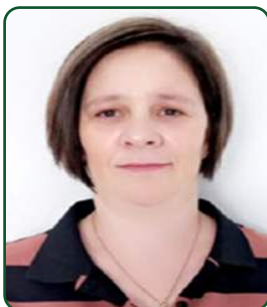

## Year in Review

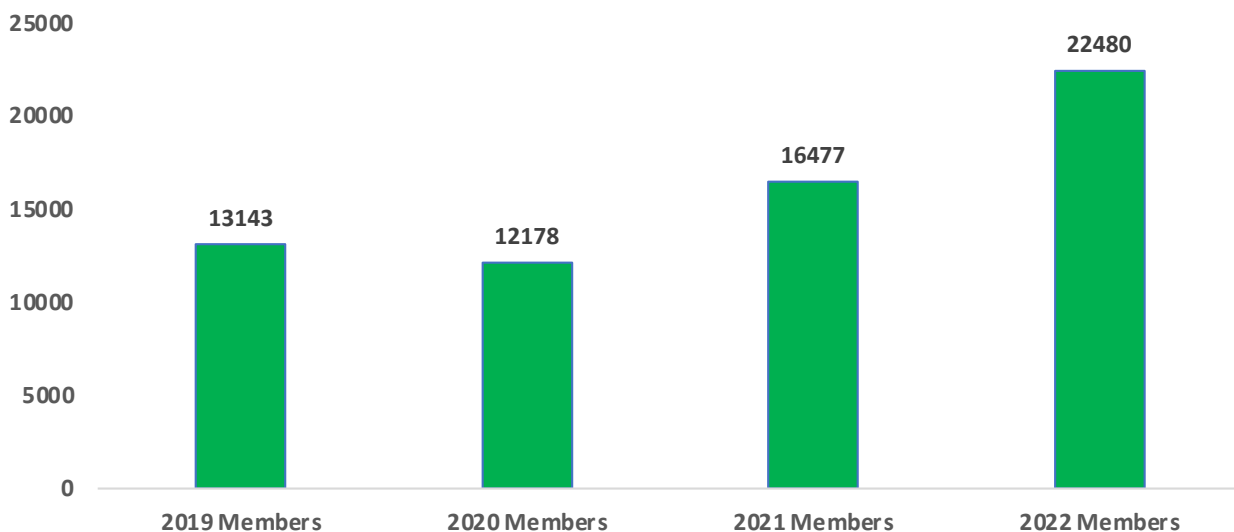
### Membership Figures

## Competition Update

### Twizza Club Championships

This competition gives every netball player the opportunity to play competitive netball in their district.

The quality of performance on court was noticeable and the increase of registered membership is testimony of the popularity of the competition.



### Telkom Netball League:

This competition is focused on high performance competition and brings the top players together to go head-to-head on the court.

TNL does not only develop the players, but also the coaches, umpires, technical officials, and administrators.

The platform allows NSA to identify future national players and test volunteers' capabilities. Encouraging netball to be a sport for supporters by including "sportainment" through the addition of music and dance involving the supporters and SuperSport viewers.

### Telkom Netball Championships U/17,18 and 19:

An investment by Telkom in the youth, this competition is the platform for players to be identified for the U/21 Netball World Cup presented every four years.



### SPAR National Championships:

One of NSA's biggest properties – districts can send their senior teams and U/21 teams. This is a very enjoyable competition for players who does not always get the opportunity to travel, stay in hotels and be fed by the wonderful ladies of SPAR – Charlene, Retha, Elsabe, and Marlene have shown us so much support as the SPAR ambassadors and friends of NSA and the SPAR Proteas.

### Male Netball Championships:

Netball South Africa acknowledge the male netball players as our members in the districts. We provide opportunities to all and ensure they fully benefit from their membership, which is essential. Males have registered and joined the netball family. We do not yet have a sponsor for this property but are actively working on it.





## Commonwealth Games

The 2022 Commonwealth Games took place in Birmingham from the 29<sup>th</sup> of July till the 7<sup>th</sup> of August. With the significant investment made into the team and extensive preparations, the expectation was very high for the team to perform and compete at the tournament.

Prior to the tournament the team travelled to Bath and Wales for some warm-up matches and showed positive results leading into the competition.

The performance of the team did not meet the expectation and the team finished a disappointing 5<sup>th</sup> position at the tournament – 1 position outside their current World Netball Ranking status.

This competition, a dress rehearsal for next year's World Cup highlighted several key areas that need to be strengthened and plans are underway to ensure that the team are provided with the best possible support to perform on their home ground next year.

We look forward to further growing and developing these partnerships in the year ahead as we strive to grow the game of netball in South Africa.

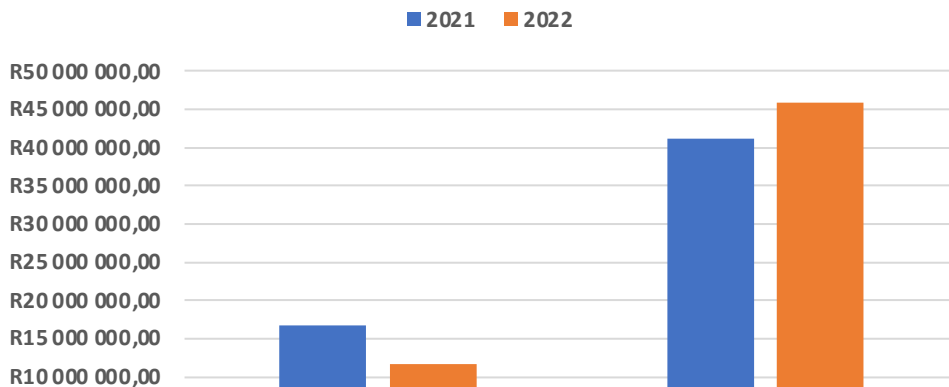

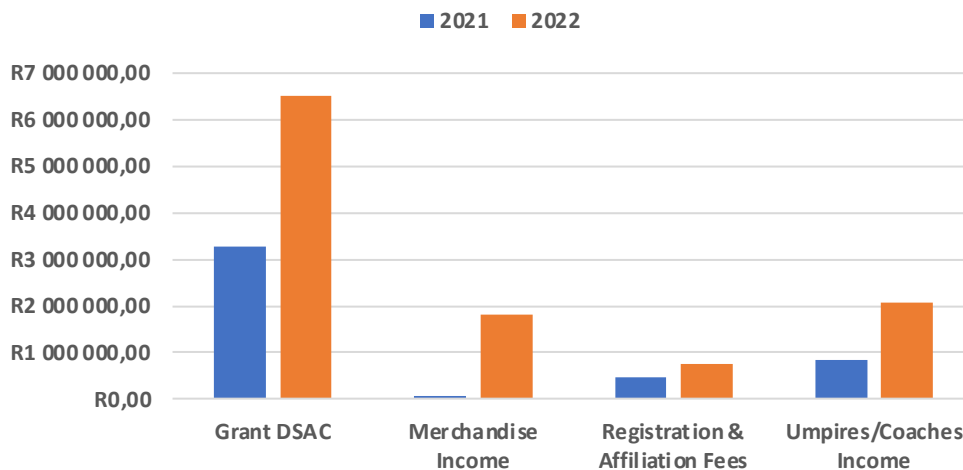
### Financial Situation



#### Other Income vs Sponsorship

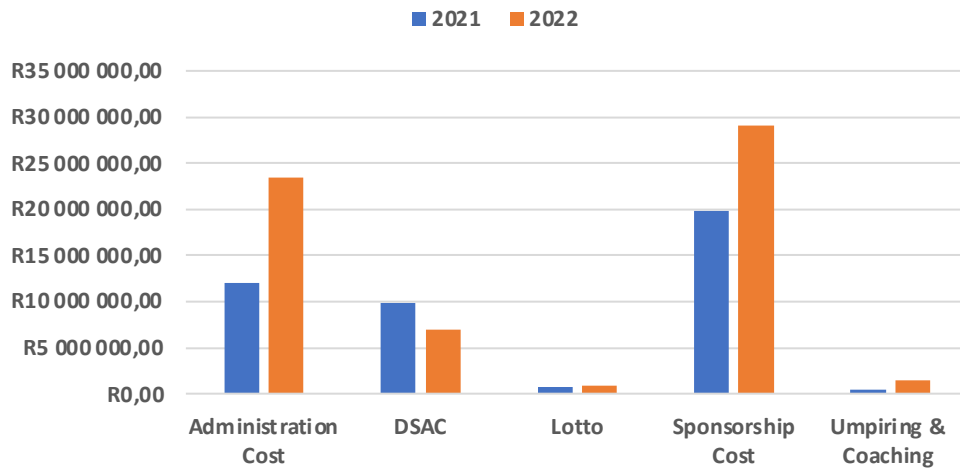


#### Income Growth

## Challenges

As much as there have been many success stories to celebrate, it is important to acknowledge several challenges that Netball South Africa are facing and if correctly approached and handled can further drive the success of the federation.

### Some of these key challenges include:

- Difficulty blending multiple personalities into a cohesive and unified team.
- Failure to develop key competencies and behaviours.
- To manage the reputation of Netball South Africa: Media statements reporting access to confidential information of EXCO meetings and quoting certain discussions the EXCO had.
- Unfinished investigating reports. Lengthy Council meetings with unfinished business.
- Members received a course to upskill themselves on the registration process through a back office system, however only 17 out of 52 districts have submitted at this stage.
- Venues to host our events becoming expensive and difficult to source.
- The uncertainty of the COVID-19 pandemic could still be a possibility to prevent the SPAR Proteas from travelling to get international test match opportunities/exposure.
- Netball South Africa requires a Board to ensure NSA's prosperity by collectively directing the Federations affairs, while meeting the appropriate interests and needs of its members.
- The Board will continue to drive the business forward and identify and recognise the EXCO's challenges



## 2023 World Cup

The countdown to next years Netball World Cup is moving at a pace and the organising committee is working hard to ensure that the tournament is a major success.

The following key objectives remain as focus areas for the competition:

- To host a world class Netball World Cup that delivers tangible benefits in terms of participation, performance, commercial return and exceeds the expectations of all principles and stakeholders.
- To deliver a commercially successful world cup that provides revenue streams for World Netball and its member federations including Netball South Africa.
- To deliver a legacy programme that changes the perception of the game and drives a sustainable coaching education plan to increase the number of qualified coaches (level 1 & 2) in Africa and USA, and NSA coaches will also reap the benefit.
- To improve, enhance and develop facilities (in the Western Cape 30 courts are being built and or renovated. Each Province will be receiving a Wooden Sprung Floor courtesy of the Department of Sport Arts and Culture as part of the legacy programme for NWC 2023
- To share the knowledge transfer programme with all our members after the world cup.

**Years ago, the anthropologist Margaret Mead was asked by a student what she considered to be the first sign of civilization in a culture. The student expected Mead to talk about clay pots, tools for hunting, grinding stones, or religious artifacts.**

**But no. Mead said that the first evidence of civilization was a 15,000-year-old fractured femur found in an archaeological site. A femur is the longest bone in the body, linking hip to knee. In societies without the benefits of modern medicine, it takes about six weeks of rest for a fractured femur to heal. This bone had been broken and had healed.**

**Mead explained that in the animal kingdom, if you break your leg, you die. You cannot run from danger; you cannot drink or hunt for food. Wounded in this way, you are meat for your predators. No creature survives a broken leg long enough for the bone to heal. You are eaten first.**

**A broken femur that has healed is evidence that another person has taken time to stay with the fallen, has bound up the wound, has carried the person to safety and has tended them through recovery. A healed femur indicates that someone has helped a fellow human, rather than abandoning them to save their own life.**

Linked to the above, it will be important that we keep our eyes on:

- Optimally supporting our national team to perform at their best and reach their full potential both on and off the court.
- Inspire women and girls through positive role-modelling to make netball their sport of choice.
- Drive the development of sustainable commercial revenue streams.
- Equip and empower our members towards excellence.

With the Netball World Cup fast approaching we have the incredible opportunity to leave a legacy in growing the game, but most importantly impacting the lives of nation. Let's together embrace this opportunity and make a real difference.

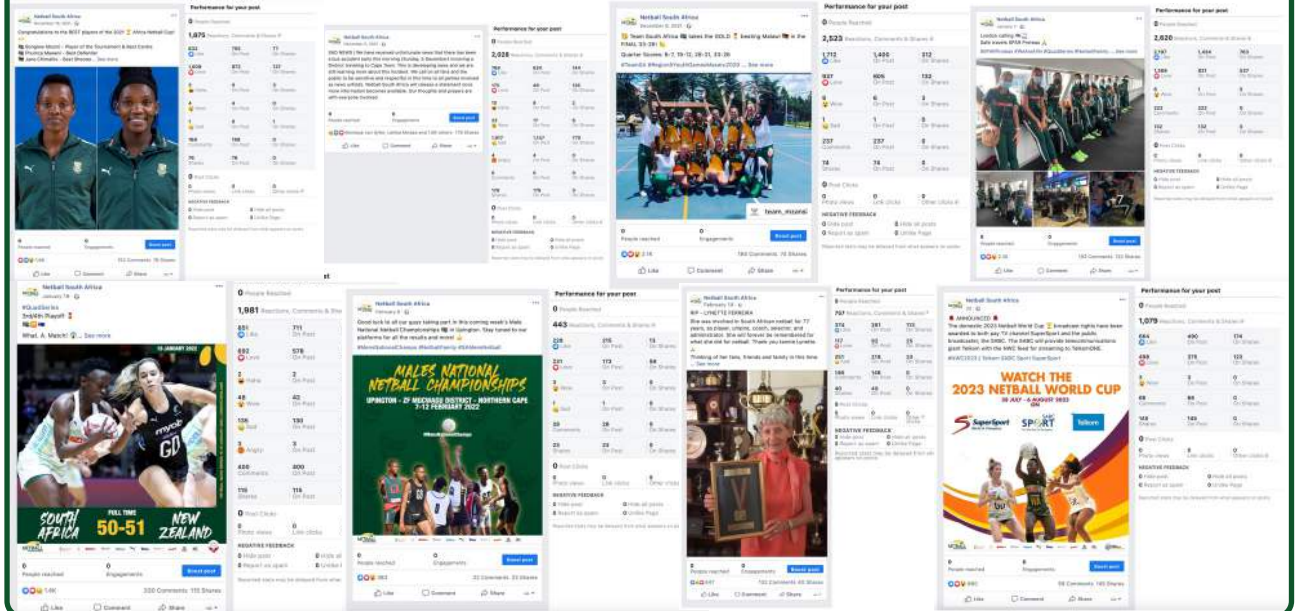



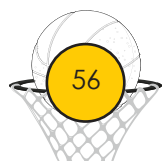

**Accounting Policies**

**1.1 Presentation of Financial Statements**

The financial statements have been prepared in accordance with the International Financial Reporting Standards small and medium-sized entities. The financial statements have been compiled on the historical cost basis. This accounting policy is in all material respects consistent with the policy applied during the previous years.

**1.2 Property Plant & Equipment**

Property, plant and equipment are tangible assets which the company holds for its own use or for rental to others and which are expected to be used for more than one period. Property, plant and equipment is initially measured at cost. Cost includes costs incurred initially to acquire or construct an item of property, plant and equipment and costs incurred subsequently to add to, replace part of, or service it. If a replacement cost is recognised in the carrying amount of an item of property, plant and equipment, the carrying amount of the replaced part is derecognised. Expenditure incurred subsequently for major services, additions to or replacements of parts of property, plant and equipment are capitalised if it is probable that future economic benefits associated with the expenditure will flow to the company and the cost can be measured reliably. Day to day servicing costs are included in profit or loss in the period in which they are incurred.

Property, plant and equipment is subsequently stated at cost less accumulated depreciation and any accumulated impairment losses, except for land which is stated at cost less any accumulated impairment losses. Depreciation of an asset commences when the asset is available for use as intended by management. Depreciation is charged to write off the asset's carrying amount over its estimated useful life to its estimated residual value, using a method that best reflects the pattern in which the asset's economic benefits are consumed by the company.

The useful lives of items of property, plant and equipment have been assessed as follows:

When indicators are present that the useful lives and residual values of items of property, plant and equipment have changed since the most recent annual reporting date, they are reassessed. Any changes are accounted for prospectively as a change in accounting estimate. Impairment tests are performed on property, plant and equipment when there is an indicator that they may be impaired. When the carrying amount of an item of property, plant and equipment is assessed to be higher than the estimated recoverable amount, an impairment loss is recognised immediately in profit or loss to bring the carrying amount in line with the recoverable amount.

An item of property, plant and equipment is derecognised upon disposal or when no future economic benefits are expected from its continued use or disposal. Any gain or loss arising from the derecognition of an item of property, plant and equipment, determined as the difference between the net disposal proceeds, if any, and the carrying amount of the item, is included in profit or loss when the item is derecognised.

**1.3 Trade and other receivables**

Trade receivables are measured at initial recognition at fair value, and are subsequently measured at amortised cost using the effective interest rate method. Appropriate allowances for estimated irrecoverable amounts are recognised in profit or loss when there is objective evidence that the asset is impaired. Significant financial difficulties of the debtor, probability that the debtor will enter bankruptcy or financial reorganisation, and default or delinquency in payments (more than 30 days overdue) are considered indicators that the trade receivable is impaired. The allowance recognised is measured as the difference between the asset's carrying amount and the present value of estimated future cash flows discounted at the effective interest rate computed at initial recognition.

Trade and other receivables are classified as loans and receivables.



**1.4 Trade and other payables**

Trade payables are initially measured at fair value, and are subsequently measured at amortised cost, using the effective interest rate method.

**1.5 Cash and cash equivalents**

Cash and cash equivalents comprise cash on hand and demand deposits, and other short-term highly liquid investments that are readily convertible to a known amount of cash and are subject to an insignificant risk of changes in value. These are initially and subsequently recorded at fair value.

**1.6 Consumable items**

Consumable items purchased are written off in full in the year acquired disclosed as expenditure.

**1.7 Department of Sport, Art and Culture - Expenditure**

For approved projects, the expenditure is incurred according to the grants received from Sport, Art and Culture SA. To ensure the accountability of the projects, any additional expenditure over and above the approved budgeted expenditure is transferred from the DSAC Income Statement to the Netball SA Income Statement as the deficit is funded by other sponsorships and income generated by Netball SA.

**1.8 Leases**

Operating lease payments are recognised as an expense on a straight-line basis over the lease term unless:

- another systematic basis is representative of the time pattern of the benefit from the leased asset, even if the payments are not on that basis, or
- the payments are structured to increase in line with expected general inflation (based on published indexes or statistics) to compensate for the lessor's expected inflationary cost increases.

Any contingent rents are expensed in the period they are incurred.

**1.9 Income and Revenue**

Revenue is recognised to the extent that the organisation has transferred the significant risks and rewards of ownership of goods to the buyer, or has rendered services under an agreement provided the amount of revenue can be measured reliably and it is probable that economic benefits associated with the transaction will flow to the company. Revenue is measured at the fair value of the consideration received or receivable, excluding VAT and discounts.

Income is recognised, in profit or loss, using the effective interest rate method. Income and revenue is generally disclosed on the face of the statement of comprehensive income. Sponsorships received specifically for a specified project is disclosed as income in the detailed notes to the projects.

**1.10 Taxation**

Tax Exemption has been granted in terms of section 10(1)(cN) of the Act.

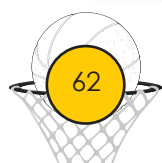

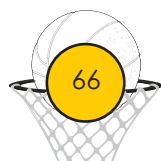

## Demarcation and Structures Report AGM - OCTOBER 2022

### 1. INTRODUCTION

23 October 2022 represents my first full year in the Director Demarcation role for Netball South Africa, and I am delighted to be able to reflect upon and report on the many accomplishments that we have achieved and touch upon the challenges that we have faced. It has been a busy and productive year and I offer my thanks and congratulations to all those who have participated, worked in, administered and supported the game of netball over this period. We are all equally excited by the growth of netball in our country and look forward to an even more successful year during 2023.



### 2. CHALLENGES

During the year we faced many challenges and the following, which is by no means exhaustive, is a synopsis of challenges faced:

1. No governance in districts and provinces.
2. Inhouse fighting in the districts. Some of which had been there for some time and members just refuse to work together.
3. No leagues or structures in certain districts.
4. Districts run without decision making positions.
5. Unhappiness of clubs and members within certain districts.
6. Protocol of members in Districts - Members bypassing their districts and provinces by contacting the NSA office directly to lodge complaints.



7. Duplication of members are still a huge concern, especially amongst our male players.
8. Districts not filtering down information to their members, especially with regards to championship rules and regulations.
9. Members not reading information sent by the office with regards to submission of required documents.

These challenges cannot be adequately dealt with by individuals within netball and it is the responsibility of all stakeholders to work together to advance the sport in their respective districts and provinces.

### 3. ACHIEVEMENTS DELIVERED

1. Restructuring of 4 districts and 2 provinces, Whereby committees were dissolved due to not proper or no governance, i.e. no leagues running for the past two years. No financial statements, no meetings held for the past year or two, no decision making positions on committees, due to resignation of committee members.
2. Certain Districts are run by one or two people.
3. Significantly improved governance in certain districts with regards to management, leadership and operational efficiencies by identifying new leadership.
4. Membership growth – A tremendous improvement in membership over the past year.
5. Constitutional workshop held to assist NSA, provinces and districts to understand what a constitution entails.
6. System Training workshops with regards to the registration system.

### 4. TRANSFORMATION

1. We have achieved so much over the past few years, but we need to achieve more and the next year presents a significant year for Netball in South Africa.
2. We know what we have to do but need the unified actions and alignment of our members and stakeholders to deliver on these and other expectations, to transform netball to its heyday of participation and prosperity.
3. The EPG department has appointed a new National co-ordinator to replace me. Bongani Mdujana who is not new to the job, was one of the Provincial co-ordinators



who received training on EPG during the national EPG training in 2020. By now you have all received the provincial data sheets and I hope that you will give the new co-ordinator the same support I received from you.

## 7. NATIONAL MEMBERSHIP DATABASE

1. Following extensive interaction with our system administrator, and invaluable assistance from district administrators who tested and provided feedback on system functionality, the National Membership registration database are active and very helpful.
2. Districts are requested to register their members on the system during 2023 to allow us to get the NSA registration and database up to standard.
3. A number of training sessions were conducted with District administrators and support are given to enable administrators to use the database effectively.

### 7.1 Challenges

- District administrators not having enough or no laptops.
- Data, especially those in the rural places.
- “**BBT**” – some districts have administrators that are born before technology “BBT”, they have a challenge navigating the system or understanding how things on the web works. This will delay your districts from registering on the system.
- Some districts did not attend the training workshops.
- Not all district administrators are active.

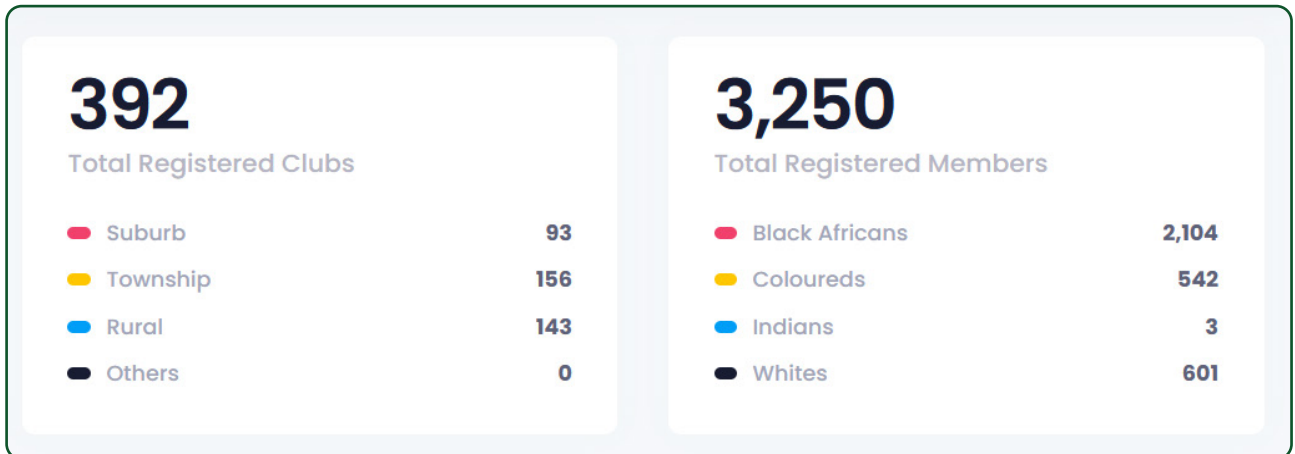

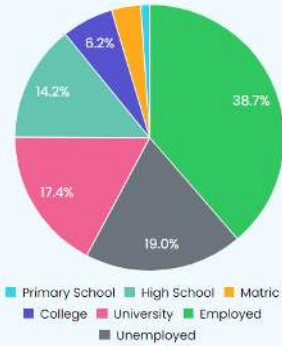

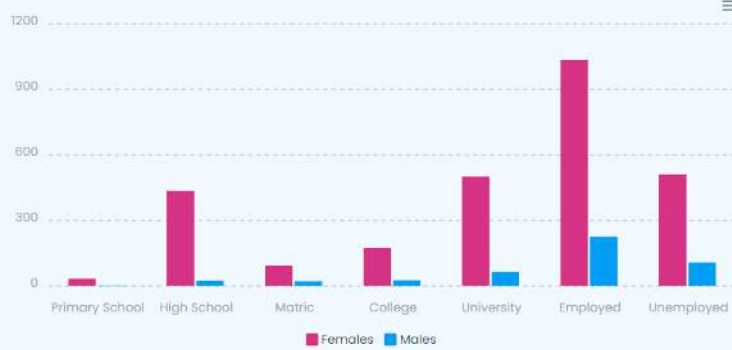

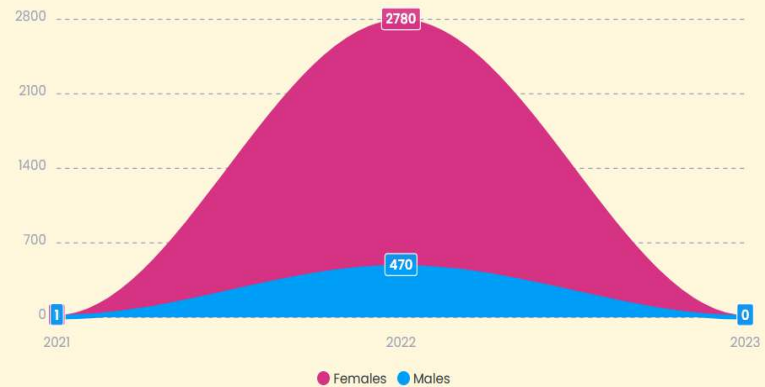

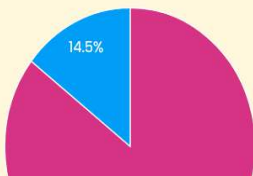

- Districts/Provinces/Associate Members can send a request to the Director Demarcation and Structures if they are interested to have these workshops presented to their members as part of their capacity building programs.

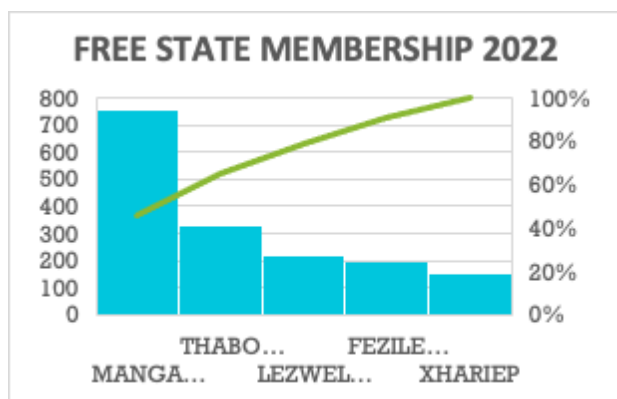
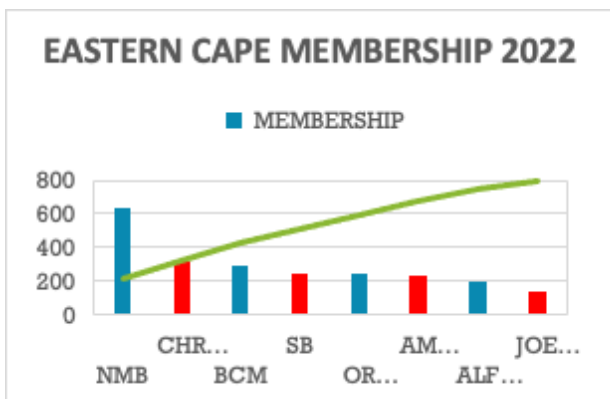

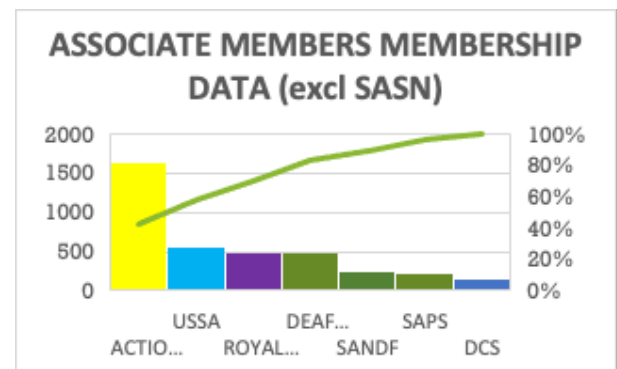
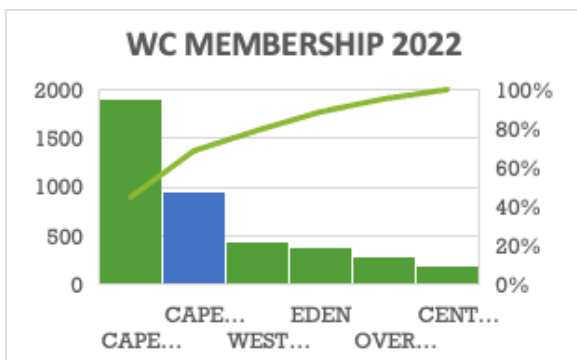
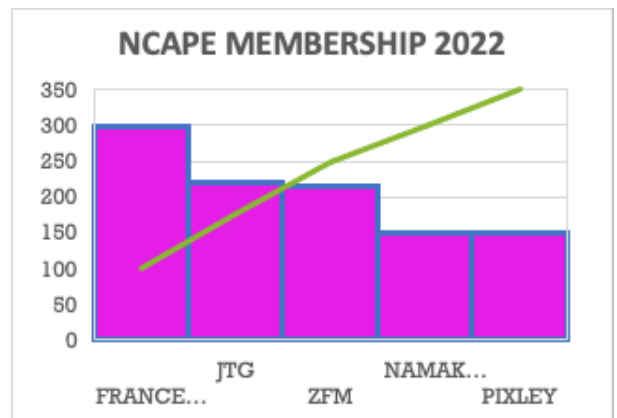
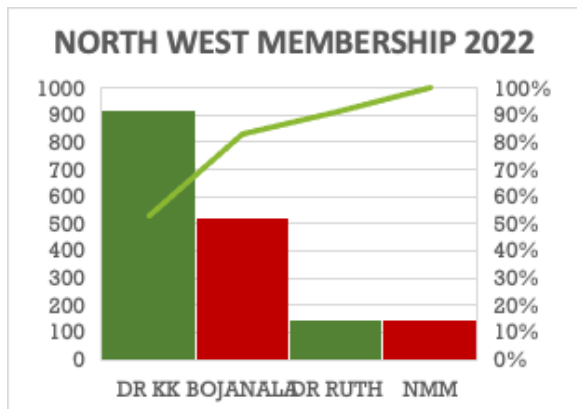
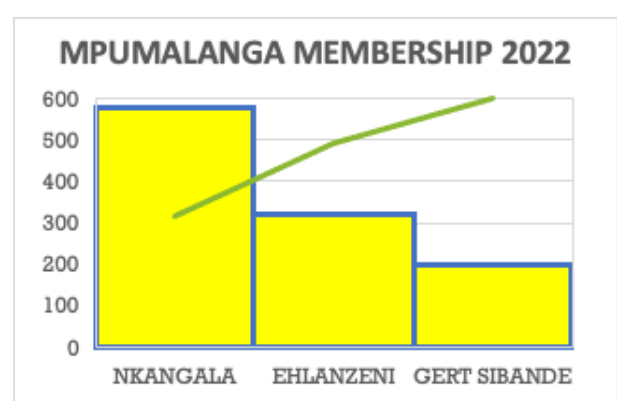
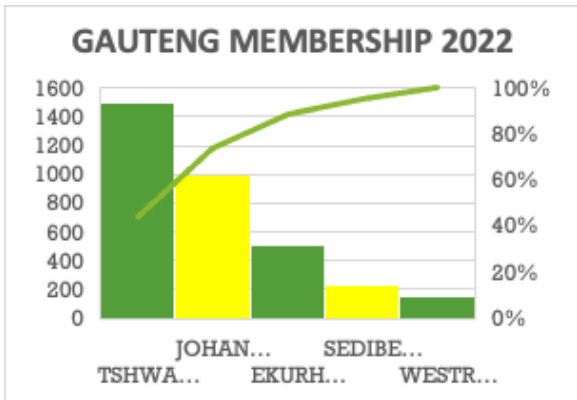
### 12.1 AFFILIATION AND REGISTRATION

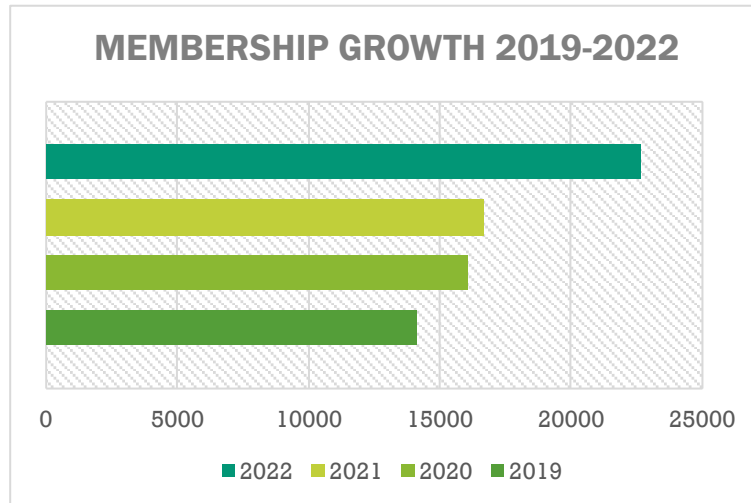

## 13. RESTRUCTURING OF DISTRICTS

1. Four districts and 2 provinces were disbanded and interim structures were put in place, due to lack of governance and inhouse fighting.
2. Districts are being reminded, that if no leagues are running, they cannot participate at national championships.
3. If finances are not managed properly or no proper structure in place, then you are dysfunctional.
4. Districts are requested to submit their structural information on an annual basis to the Director? Demarcation and Structure. Such information is requested to reach the NSA office by not later than **30 June annually**.

#### 14.1 SPAR CHAMPS

The SPAR champs brought about many challenges. This is the first time that we have had so many teams not adhering to tournament rules and regulations. A number of districts were penalised for deliberately not pitching their target on court. CTN A team felt that we were being unfair and decided that due to this, they will not pitch up for their final match of the tournament.

#### 14.2 TWIZZA

We are aware of the inconsistency regarding the different correspondence circulated to members regarding rules of TWIZZA and would like to inform members that this was already dealt with and changes will be implemented during 2022.

Questions were raised about who are eligible to participate. Despite the different rules



which went out, it was made clear to council that the TWIZZA tournament is purely focused on development.

The 2022 TWIZZA National championship has seen a major improvement with regards to participation criteria.

#### **14.3 Submission and verification of team lists.**

Team lists are received on the 11<sup>th</sup> hour. We appeal to districts to please stick to deadline dates.

Districts must bear in mind that NSA first have to verify players and management before they can go to the champs. We will not take responsibility for any player or management arriving at the champs and not being allowed to participate.

#### **14.4 Registration at championships**

Despite sending out communication on what the Team manager must bring along to registration, we still find most of the team managers arriving at registration without any documents. This is what causes the delay at registration. We urge to districts to ensure that you identify competent team managers.

#### **14.5 Age group for U19 and U21 participation**

Districts have a challenge with the rules of players turning 20 during that same year of the U19 tournament. Districts are complaining that they have a challenge with finding U19 players, as most of their young players are being poached by other districts/ universities, which leaves them with no U19 players.

## **15. CONSTITUTIONAL WORKSHOP**

1. A constitutional workshop was hosted on 25 June 2022 at Garden Court OR Tambo and facilitated by Professor Rian Cloete, who specialises in Sport constitutions.
2. The workshop was well represented by districts, Provinces and Associate members.
3. The workshop was a starting point to take NSA and it's districts to the next level by ensuring that proper governance are followed.

## **16. TRANSFORMATION POLICY**

The draft transformation policy was circulated to all for inputs. As soon as the policy is approved, it will guide and assist us to amend the By-Laws.

1. We need to distinguish between foreigners, asylum seekers and refugees, to ensure that we don't discriminate against anyone.
2. A refugee may apply for South African citizenship provided he or she: has been granted permanent residence in South Africa or has been an ordinarily resident in South Africa for a continuous period of 10 years. As a recognized refugee (section 24) you have the right to seek employment in South Africa, under the amended Refugees Act.
3. An asylum seeker is a person looking for protection because they fear persecution, or they have experienced violence or human rights violations. As an asylum seeker you do not automatically have permission to work in South Africa while you are waiting for the outcome of your asylum.
4. A foreigner is a person born in a different country, or an outsider. A person who is temporarily in the country and who does not have any citizenship.

# NSA DIRECTOR Coaching Report AGM - October 2022

Annelie Lucas

## 1. SUMMARY

I believe that everyone has the potential to achieve something remarkable. All they need is someone to help them discover the way to be all they can be.

NSA deliver coaching programs for all coaches in South Africa and we want to help all our coaches to do what they do, better. We want you to "FIND YOUR FIRE".

Realizing your potential as a coach, is all about discovering your FIRE; that light that's burning inside you that's always been there, that little voice, that driving force, that you know is at the core of who you are. I see my role as the Director coaching to assist by developing programs that will help you to unleash that fire, and how to use it to ignite your very best performance as a coach.

## 2. COACH EDUCATION

We are in the process of reviewing, updating, and changing our coach education. This is a tedious process aligning with World Netball and the ICCE to meet international standards. NSA through the Director Coaches train and educate all coaches in South Africa.

We encourage members to renew membership in time. We're updating the National database for coaches, as the new Director I did not receive any contact information on current members. This is a problem as we cannot communicate with members on a regular basis. We rely on Provinces and districts to distribute important information. We want to introduce our new education system to you as members and hope you find this more user friendly.





It came to my attention that our coaches and members are confused about our current accreditation system especially the inconsistency in the authentication of the RPL process through SASCA. NSA NCA members have no obligation to become a member of SASCA. SASCA is a private company offering various sports coaching designations for the community of professional sports coaches in South Africa. Only when legislation passes will they be recognized as a professional body for sports coaches.

The learning process is vital to all coaches, irrelevant of the accreditation level they hold. Some coaches have ambitions to coach at the highest level they can attain, while others take great joy in coaching foundation level players. Both these scenarios are welcomed and encouraged. What remains at the core for all coaches is a commitment to learning and the broadening of their coaching skill set, relevant to their needs and the needs of their players. Coaching will always remain an ongoing pathway where coaches need to utilize opportunities afforded to them.

## 2.1 MEMBERSHIP

Any **registered member of Netball South Africa** who is a Coach may apply for membership. Individuals who are not a registered member of NSA are required to register with a club in the district in which they work, study, or reside.

Accreditation is granted to Coaches assessed as competent by CD's.

Membership fees as recommended by the NCC.

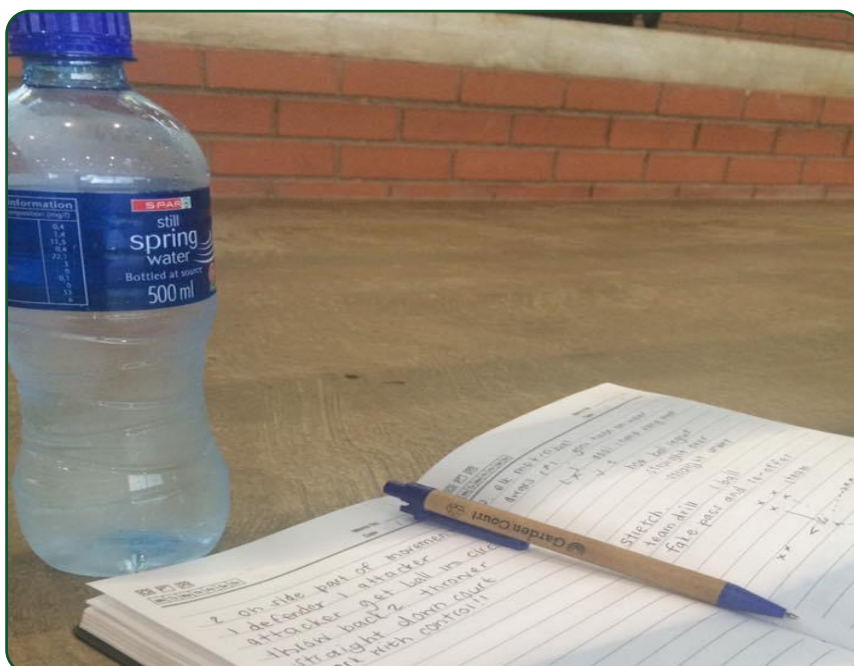
Membership fees to be renewed every three years, subject to compliance with Continuous Professional Development.

A membership card and certificate will be issued on accreditation.

It is a Criminal Offence to falsify NSA Coaching Certificate and/or Card.

It is a Criminal Offence to apply for coaching positions with an expired accreditation card.

Refer to safeguarding policy and coaches code of conduct.



### 3. COACHING COURSES

## 4. NSA COMPETITIONS

### 4.1 INTERNATIONAL

Preparation building towards Commonwealth Games included a training camp in Stellenbosch, games against Malawi and England as well as matches against Wales.

Coaches' preparation included a 7-day tour visiting all players, playing in the UK Vitality league, (accompanied by the mentor coaching staff included Norma Plummer.

Tired, Over-played, burnt-out with no visual game plan. Words that described the performance of our National Squad. A disappointing 6<sup>th</sup> at the Commonwealth Games with a back-to-back very poor performance at the Africa Qualifiers where we took 1<sup>st</sup> position.

We have adaptable players in the National squad. Players can adjust to situations on the day. Each player knows exactly what is expected from them. We expect better results.

Our Males netball team had a very successful tour to St. Vincent and Grenades. Although inexperienced, the coaching staff showed commitment to the program and tried their best. A well-positioned second place.

### 4.2 TNL

We again realized the importance of training and educating our TNL coaches. With clear guidelines on duties & responsibilities of the management.

Most coaches don't have the luxury of an assistant coach. However, the coaching staff should ensure that the roles each individual play, as part of the management should be clear to assist players to be the best they can be on the court.

The management team should strive to maintain a professional image for their teams and provinces.

We've included mentor coaches as well as with two teams 2 assistant coaches, however this role still needs to be clarified and management trained accordingly.

Coaches should be reminded that ethical coaching entails doing the right thing. It requires the courage to consistently make morally sound choices; not merely comply with rules or mandates. Managers are not allowed to coach. They are not the coaches. All coaches should register in time with their respective teams, and we encourage coaches to attend the coaches meeting at the various tournaments.

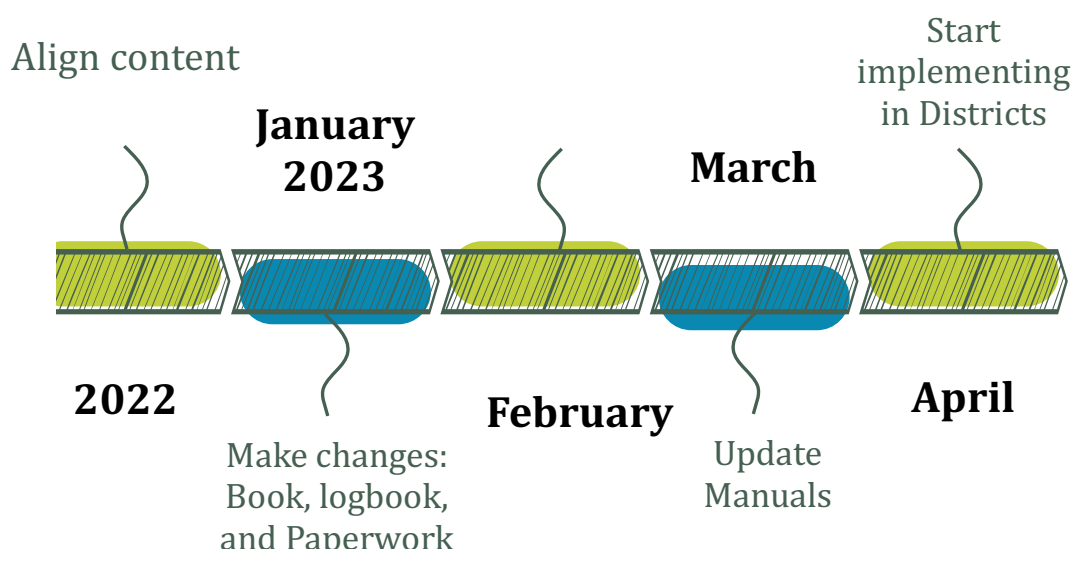

### o High Performance Centre – Stellenbosch

Daily Performance Environment - The planned residential program at SAS started in September. This is to present players with DTE (Daily training environment). Nutritionist and cycle monitoring to be added on platform. Sports Nutritionist is Sarah Chandler, PhD from Leeds University. ## 3. Telkom Netball League

- The 2022 Telkom Netball League season 2022 was played across two provinces over eight weeks. KwaZulu Natal (KZN) hosted the opening power week of the tournament from 27 April until 2 May 2022, and matches were played at the Olive Convention Centre in Durban.

- The focus were on the TNL as we are getting ourselves ready to host the World Cup in 2023 and that was a perfect opportunity for the National Coaches to also scout some players for next year.

- TNL is South Africa's premier netball tournament and has been the leading netball competition contributing to the development of many players. TNL provided a great opportunity for players to prepare, compete and work hard in order to be noticed and scouted. From the 2022 TNL, 17 players were scouted
  - o Free State Crinums (2),
  - o North West Flames (1),
  - o Gauteng Golden Fireballs (6),
  - o Gauteng Jaguars (6) and
  - o Western Cape Southern Stings (2) have all been offered netball contracts.
- Most of the SPAR Proteas players were in action, and that also gave the Coaches an opportunity to assessed players that were going to Commonwealth Games in Birmingham.
- The league comprises of thirteen teams from all the nine provinces with Gauteng, KZN, Eastern Cape and Western Cape each having two teams. The Eastern Cape Aloes who are also Division B Champions for two years in a row had defended their title for the third time and are moving to Division A next year 2023.
- It was good to see the return of fans for the first time since 2019 coming into the arenas to watch netball after lockdown restrictions being lifted.

Uganda ran down the clock with patient play for the final 2 minutes with the full-time score South Africa 48 – 54 Uganda, meaning **Uganda finished in 5th place whilst South Africa finished in 6<sup>th</sup> place.**

## 7. ALL AFRICA QUALIFIER GAMES

Please find below the Reports of All Africa Qualifier Games held at Tuks in Pretoria. Players were given their individual reports. The **Africa Netball World Cup Qualifiers** were held in Pretoria, between 21 August and 27 August 2022, with nine teams taking part. South **Africa**, while still participating in the tournament, had already qualified for the **World Cup** due to being the hosts, leaving eight teams to compete for two **qualifying** places.



Teams competed in two pools, with each team playing every other team in the pool. At the end of the pool stage, the first-place team in each pool played the second-placed team of the other pool, with the winners playing each other in the final and the remaining teams playing each other to determine 3rd through 9th place. The top two teams of the tournament (excluding South Africa) qualified for the Netball World Cup

Recently, the top six qualifying teams were announced for the 2023 World Cup and they contained South Africa and Uganda. Uganda chose not to take part in these qualifiers, but South Africa were still there as hosts. The top two teams from the tournament (apart from South Africa) qualified for Cape Town next year.

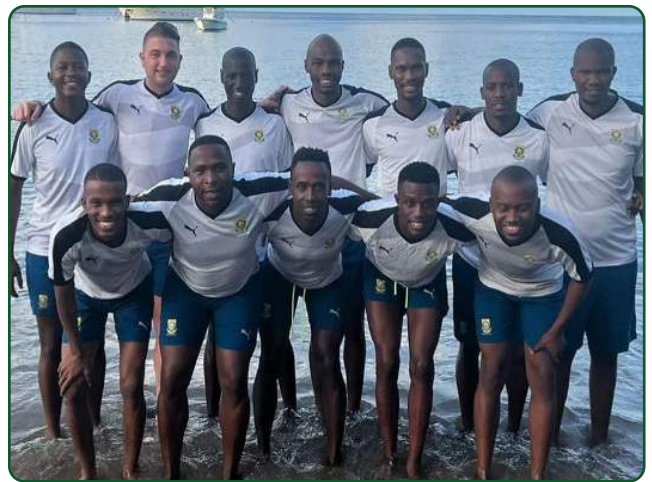
